I understand that the use of the leased football equipment is not in any way a guarantee of the prevention of any injuries, damages to the user, and hereby release the Program, the Schools, Colleges, and Universities where the camps are held including but not limited to (Limestone College, University of St. Thomas, Robert Morris University, George Mason University, Trinity International University, University of San Diego, University of Massachusetts-Lowell, Drew University, University of North Texas, University of Houston, Towson University, Pacific Lutheran University) (the "College"), its officers, staff, agents, affiliates, and employees, any and all Sports International Staff, its employees, sponsors, volunteers, directors, officers and owners, any and all NFL players past and present that may be at camp for any injury or damage which may occur to the minor child, including all risk connected therewith, whether seen or unforeseen. I further agree to save and hold harmless the College and the Program and the otherwise mentioned parties from any claim by the undersigned or the minor child using the football equipment, or the child's estate, heirs, or assigns, other than for actual negligence of the College or the Program or its agents. I specifically recognize this agreement does not constitute a waiver of any claims against the manufacturer of the equipment arising out of defective manufacture or design of the sports equipment or alleged breaches of any warranties concerning such equipment, but agree and understand that I knowingly agree to indemnify, release and hold harmless the College and the Program and other mentioned parties for any such defects in manufacture or design of such equipment or alleged breaches of warranties of such equipment. I also knowingly and voluntarily indemnify, release and hold harmless the College and the Program and other mentioned parties from any and all liability, claims, demands, losses, damages, and costs including without limitation reasonable attorney's fees, fees that arise out of or in connection with any personal injury to the Child or others, accidents, delay, property damage, and/or other loss or expenses of any kind suffered by the Child in connection with the Child's use of the leased football equipment.
